INTRODUCTION: RESPONSE TO STATEMENT BY COGTA: ON DIRECTIONS FOR RELIGIOUS GATHERINGS

This Letter serves to confirm that we have received this recent Statement by the Minister of COGTA - Cooperative Governance and Traditional Affairs – **Dr Nokosazana Dlamini Zuma** – on the Directions for Religious Gatherings. This has been issued on the 29th May 2020 in terms of regulation *37 (1) (a) of the Disaster Management Act 2002 (Act Number 57 of 2002.)* We recognise she is the same MEC who is in charge of the National Disaster Management Council - and who has 'claimed to have consulted' with all other cabinet ministers before making these decisions to restrict and control the freedom of religion in South Africa. These Regulations are believed to apply to the **Alert Level 3** during a COVID 19 Lockdown.

BACKGROUND HISTORY: This Letter is also the response to an acknowledgement from the Office of the President of our Letter sent on the 28th of April; and that requested the Summary of Findings on both a Zondo Commission and also the Anti-Corruption Tribunal from The National Peace Commission. There is also a need to understand the intentions of the present Government with regard to all this COVID 19 – and the motivation to close down the entire economy: place the entire country under house arrest as well as remove or control the Freedom of an entire country - all in the name of safety and good health. It is of serious concern to the business chambers - the 80% Christian majority - and also all civil society!

THE PRESENT SITUATION: This Letter - with the attachment – serves to provide the President; and that Cabinet of 28 Ministers with what is believed to be the present State of the Nation; and the perception of that is our own Summary of Findings. South Africa is a Covenant Christian Country with 80% of this population and 66% of all people of the African tribes and nations embracing the Abrahamic Families of Faith. It is of concern that Chinese police stations and personnel are being brought into South Africa as well as Cuban doctors when there are unemployed and capable people to deal with the challenges of a COVID 19 Lockdown. The relationship with China - and the trade agreements need to be revealed to us.

THE PRIMARY AIM AND OBJECTIVE: This Letter and the attachment of the Summary of Findings is also 'respectfully' provided to inform the Office of the President and Cabinet of 28 Ministers that it is clear a present Government does not serve either the people or the Almighty God of The Holy Bible and this is evident in The Constitution: The Bill of Rights: and these BRIC Trade Partners are witness to this reality.

The Church will not be regulated or controlled and neither will the Freedom of Religion be removed by a Government that does not recognise the Sovereign Power of Almighty God – nor respect the beliefs and needs of 80% of the entire country. In the absence of the Fear of Almighty God there will never be peace and freedom in this country of many races: tribes: cultures and nations. **We need that Freedom!**

THE NEED FOR SEPARATION OF POWER: This Letter and the attachments and Summary of Findings is a Notice to the Office of the President and the 28 Cabinet Ministers that matters of State and The Church are at all times separate; and the one cannot regulate or control the other. The Civil Government is The First House - and requires the Voice of Truth: Reason and Wisdom from The Second House – and which is established to provide guidance and direction on all social: economic and political matters; and this is wisdom provided by The Word of Almighty God. There are three main Faiths in South Africa that really have their foundations in The Holy Bible and we need the Government that serves the God of the Holy Bible and that bases all decisions on Biblical Principles and Godly Values. These represent Truth: Justice and Righteousness – and every single other Faith or Religion in South Africa will embrace these values.

The Attachment is clear on what is expected of a Godly Civil Government that serves the Almighty God of The Holy Bible – and there are only Ten (10) Principles to achieve Peace and Freedom; and this is not a Christian thing: and neither is it a Jewish dictate or even a Muslim issue – but it does guarantee peace and freedom from tyranny: oppression - and despotic rule. Separation of Power is demanded in all Civil Government – and that applies to the Executive: Legislature and Judiciary and in the absence of this, it is centralised control that was found only in Nineveh: Egypt: Babylon and also in Communist Countries.

THE REAL NEED FOR THE SECOND HOUSE: The Church is represented by the 80% Christian majority as well as more than 75 865 churches and more than 150 different church denominational groups in this country – and no government will be able to regulate or control what is of Almighty God – and it does not have the right: ability or the Supreme Authority. The National Interfaith Council of South Africa or the South African Religious Forum and a CRL Rights Commission and Peer Review Council are Chapter Nine Organs of State - that also want to regulate and control The Church. The Disaster Management Council under the MEC for Cooperative Governance - and Traditional Affairs – COGTA – has no ability: right or even authority to regulate and control an organism of God-fearing: Bible-believing Christians.

The National Peace Commission was established by the South African Christian Chamber of Business – and it is The Second House. The Voice of Truth: Justice: and Righteousness is needed in the country as truth is seldom seen: justice is delayed or denied: and righteousness is never recognised: or rewarded. The Second House is represented by those in the 80% Christian majority and all other religions and it is also represented by Captains of Industry and Mind-Leaders in Commerce: as well as people in all Civil Society that want peace and freedom. People from the informal sector - and even those 550 informal settlements in Kwa Zulu-Natal – are represented in The National Peace Commission that want peace!

THE ROLE OF CIVIL GOVERNMENT: IS TO SERVE: Civil Government is represented by the Executive or President and the 28 Cabinet Ministers that have limited jurisdiction – and their duty is to serve those people in our country. The 1997 Batho Pele – People First – Principles were promised to the country in every single one of the 9 provinces and 234 municipalities – and all public servants need to implement these Eleven (11) Service Delivery Principles. The role of Civil Government is to protect and defend all the people - and fulfil the 1955 promises of The Freedom Charter – and to uphold that Sanctity of Life.

The National Peace Commission needs clarity and accountability from the President and a Cabinet on:

- 1. The Summary of Findings on that Zondo Commission that has cost more than R400 million.
- 2. The Summary of Findings on the Anti-Corruption Tribunal that has no oversight committee.
- 3. The Summary of Findings on the COVID 19 Coronal Virus and justification for the Lockdown.
- **4.** The Summary of Findings on the Chinese Trade Agreements and the relationship with them.
- 5. The Summary of Findings on the Chinese and World Bank Loans and obligations to all them.
- **6.** The Summary of Findings on all these World Health Organisation Partners: and the intentions.

RE: FINAL DEMAND IN TERMS OF SECTION 3 OF THE INSTITUTION OF LEGAL PROCEEDINGS AGAINST CERTAIN ORGANS OF THE STATE ACT 40 - OF 2002.

The Above Matter Refers: We write on behalf of The National Peace Commission – The Council of 28 – that has been established by The Christian Coalition and S.A Christian Chamber of Business (PTY) Ltd in October of 2019 as an Ethics Committee and we being duly instructed by it hereby address the concern South Africans have for the future of our economy: our country: and Christian Faith: and freedom as an 80% Christian majority. More than 66% of all the African tribes or nations of Zulu: Xhosa: Ndebele and Swazi people – including the indigenous Khoi San nation – embrace the Christian Faith and are actually therefore represented in all sectors of the mainstream economy: civil society: as well as people in both the public and private sector. The Government of South Africa has limited jurisdiction in terms of both The Constitution and a democratically elected political process - and not one single person – including the president of this country - has the ability: right: or authority to dictate: regulate or control the lives of more than 60 million people based on their perceived understanding of what is in the best interests of a country of many races: tribes and nations and the motivation to place the President and Cabinet of 28 Ministers on Notice is due to the recent and past actions and acts and omissions of a present regime that mistakenly believes it is both above the law and is entitled to make decisions outside of their legal: and Constitutional and parliamentary right and mandate. This Letter to the Office of the President has a single purpose and that is to demand accountability - and is addressed to the following Cabinet of 28:

Gwede Mantashe: 28: Fikile Mbalula: 29. And Ebrahim Patel. These are the Cabinet Ministers that were appointed and elected to serve the country.

It was Margaret Thatcher - Prime Minister of Great Britain - that made a statement: "The Government has failed the Nation. It has lost credibility and it is time for it to go. Let us never forget a fundamental truth that the state has no source of money which they earn themselves - It is only taxpayer's money!"

SOUTH AFRICA: THE ROLE OF CIVIL GOVERNMENT: TO SERVE THE PEOPLE: BATHO PELE: PEOPLE FIRST:

The role of the President and the Cabinet of 28 is to serve the people and in 1997 the Government had provided the Eleven Batho Pele – People First – Principles for Service delivery in both the public sector: in every single organ of state: and municipality in South Africa – which have been ignored by leaders in management and the recent Military Lockdown has revealed both that need for service delivery - and also accountability for the actions and acts and omissions that clearly disregard the rights of the people and the need for the Rule of Law and adherence to The Constitution: the Bill of Rights: and those Batho Pele Principles. This Letter serves Notice on the Government to adhere to all these dictates; or face the consequences of poor judgement calls and the failure to respect life: property and the rights of others.

The Power of the Government does not rest in the hands of a few self-appointed or elected officials as the National Disaster Command Council would want the country to believe – and neither does it also in any way rest in the hands on either the president or any single person and this is neither democratic or in keeping with the principles of democracy. Attention is drawn to the recent Government Gazette 659 on the 28th of May 2020 – where a Minister of Cooperative Governance and Traditional Affairs - COGTA - issued directives and notices in Number 43365 pertaining to the regulation and also the control of the entire 80% Christian majority and more than 75 865 churches with more than 150 separate or different denominational groups. There is not a single person in this country that has all that right and ability: or that authority to dictate what can take place and neither can any Chapter Nine Organ of State – as seen with the Cultural: Religious and Linguistic – CRL – Rights Commission – remove the right to a basic right to all Freedom of Religion: Speech: Expression: or Movement and it is not only anti-democratic but it is also seen as a relentless attack on these Constitutional rights of all the religious leaders in South Africa.

The Role of the President and the Cabinet of 28 and Civil Government is to serve the needs of people in a manner that is in keeping with these Batho Pele – People First – Principles and the MEC for Economic Development: Tourism: and Environmental Affairs – **Mrs Nokosazana Dlamini Zulu** – abused a position of public service to impose a totalitarian rule under the Disaster Management Act 57 of 2002 to suit an unknown agenda that is neither Constitutionally correct nor in line with democracy and is dictatorial at best; and totalitarian rule at worst. It is tyrannical at best and oppressive at worst; and there is also not enough evidence to justify all the extreme measures taken by government to deal with this COVID 19; and the truth is yet to be seen. The authority does not exist and the Government Gazette can be seen at www.gpwonline.co.za. The ability and right is then brought into question - and these issues include:

The Power of more than 60 million people and the 80% Christian majority cannot rest in the hands of a single president or cabinet minister – or even a small group of people in a National Disaster Command Council. On the 29th of April the same minister of Economic Development: Tourism: and Environmental Affairs made a public statement that related to the banning of tobacco products - and once again had a television briefing of the Regulations for Level 4 of the Military Lockdown - and also made the following claims in support of the justification in response to the application made by the Fair Trade Independent Tobacco Association - FITA— to have the ban uplifted. She claimed there were 2 000 submissions - that had opposed the application by FITA and there were only 1 535 submissions; and the claims were false.

- 1. 47.2% of these 1 535 opposing submissions had nothing to do with smoking or use of tobacco.
- 2. Only 23.3% were actually in support of a banning of tobacco and other smoking related issues.
- 3. 29.6% actually supported the banning of cigarettes and the figures had been manipulated for it.
- **4.** Only 454 submissions actually supported the banning of tobacco and they had all been inflated.

The Role of the President and the elected government is to be ethical and it is a matter for **The Church**.

SOUTH AFRICA: THE NATIONAL DISASTER: THE MILITARY LOCKDOWN: THE IMPACT ON THE ECONOMY

South Africa prior to the COVID 19 was in Junk Status: Economic Recession - and in desperate need of a National Action Plan to generate a vibrant economy and put an end to the 50% unemployment and the increasing crime: grime: and inner-city decay. In addition to this the Zondo Commission had been in the process of exposing the corruption and the President had established the Anti-Corruption Tribunal to in fact recover R14 billion in money lost to the economy by corrupt public servants. These were both put on hold due to the perceived threat of the Corona Virus and which has proven to be destructive to this economy and the military lockdown has resulted in the destruction of the economy and also increased poverty: unemployment or crime: and ministers in Kwa Zulu-Natal are seeking support from all sectors.

The KZN Minister for Economic Development: Tourism: and also Environmental Affairs – EDTEA – MEC **Nomusa Dube Ncube** - advertised to gain support for her efforts to provide a Budget Speech on the 2nd of June 2020 in the KZN Legislature. Her appeal for Budget Speech Preparedness support highlighted a desperate need for catalytic projects to create a vibrant economy; and also a deficiency in leadership in the critical areas that are essential for socio-economic growth and development. Local Government is a service provider for investors and captains of industry and mind leaders in commerce - and a corporate sector that is the only sector that can stimulate the economy or all sectors of industry. The State is also responsible to ensure that spatial development and bulk services are made available - to provide those essential infrastructures for effective and efficient service delivery and it cannot generate an economy.

Crime is the enemy of the tourist industry and the economy - and corruption is the enemy of the poor: and a hatpin in the heart of the destitute: needy and all socio-economic growth and development. It is the lack of infrastructure and poor Batho Pele – People First – Service delivery that is the enemy of the entire country and the investors that are the life-blood to any vibrant economy. The Government does not create jobs and growth can only be achieved in the informal - and also a Small: Medium: and Micro Enterprise – SMME - Sector – and yet the government chose to declare a National Disaster: a Military Lockdown: and closure of the entire economy - while other economic development ministers were all preparing for Budget Speeches in the Legislature - and this defies all logic. The National Minister for a Department of Cooperative Governance and Traditional Affairs wants to regulate and to control the 80% Christian majority and ban certain products essential to the economy – and defies all basic logic!

The KZN Minister for Economic Development: Tourism: and also Environmental Affairs – EDTEA – MEC **Nomusa Dube Ncube** – advertised the following information to gain support for her Budget Speech on the 2nd of June 2020 in the middle of a National Lockdown. The reader can be the judge of this appeal.

The Priority Areas include: 1. Access to Finance: 2. Lack of Funding: 3. Job creation: 4. Poverty Relief: 5. Food Security: 6. Removing barriers to growth - and obstacles to development and: 7. Black businesses.

The Priority Questions include: 1. What should be done to grow an economy? 2. Which sector must be given the most attention? 3. What must be done to drive a rural and township economy? 4. What can be done to strengthen partnerships in the private and public sector? 5. What can be done to deal with the crime and corruption? 6. What tips can be provided to roll-out the digital infrastructure? 7. What is suggested - and should the entrepreneurial revolution be followed to provide the solution to all of this.

South Africa desperately needs socio-economic growth and development and investor confidence; as it is clear that this government has failed to understand all the social: economic: and political challenges.

SOUTH AFRICA: THE NATIONAL DISASTER: THE MILITARY LOCKDOWN: A NEED FOR ACCOUNTABILITY

South Africa has become a casualty of the COVID 19 Pandemic and the South African Government has chosen to follow the countries that support that closure of the economy: the house arrest of millions: and obey the instructions of the United Nations and the World Health Organisation. There is clearly a global movement to promote mandatory vaccines: microchip tracking systems: 5G technologies: and cashless society: and these interest groups are being investigated: exposed and prevented from being able to embark on depopulation programmes that affects the poor: and also destroy the economies.

A Letter was sent to the Office of the President and the 28 Cabinet Ministers on the 28th of April 2020; requesting clarity on our concerns as to the level of commitment the ANC Government was involved in these programmes. These areas of concern include the motivation to resort to extreme measures that clearly are not justified and have also resulted in abuse of power by members of the SAPS and SADF in incidents of arrest: and even the death of several people including Collins Khosa. Millions of people in South Africa have been adversely and negatively affected by the Military Lockdown and destruction of the economy. These areas of concern include the lack of food security - and poverty and disaster relief.

South Africa has become a casualty of both the COVID 19 Pandemic and the past 26 years of corruption and inept management of this failed African state. This real truth can no longer be opposed: denied: or even disputed and ignored. The Letter requesting accountability and collaborative cooperation was the one sent out of respect for the Office of the President; and it provided the areas of concern regarding a Military Lockdown: the Zondo Commission: the Anti-Corruption Tribunal and the motivation to close an economy that was already in free-fall. This clearly was of no real or significant interest; and although an acknowledgement was received, none of these areas, or issues, was dealt with in any reasonable way and meaningful manner. It was therefore important to follow that up with this Letter of Final Demand.

A Letter was sent to the Office of the President and the 28 Cabinet Ministers on the 28th of April 2020 in an attempt to gain some insight into the motivation and justification for the extreme measures that were taken to deal with a seemingly small health threat – and no more dangerous than the already 60 murders a day: 56 000 deaths from tuberculosis and 19 000 deaths as a result of influenza in 2019. This Military Lockdown: SADF and Chinese police intervention: and the Cuban medical teams has not been a method that can be easily understood by most of the people in South Africa and it most certainly is not one that can be readily accepted by those who have lost businesses; or suffered in the informal sector or those living in 550 informal settlements in Kwa Zulu-Natal. It is not in the best interests of a nation!

South Africa has become a casualty of both the COVID 19 Pandemic and these past two months of poor judgement calls - that has led to a Humanitarian Crisis: Black-Market criminal extortion - and increasing levels of poverty: pollution: unemployment: homelessness: and a dependency on the government for a variety of essential needs. In addition to these, the people of this country have relied on the president - and a Cabinet of 28 Ministers to make decisions regarding the economy and future of the country: that clearly they had no right: ability or authority to make in the absence of parliamentary approval: and the collaborative cooperation of interest groups that have not been consulted - or even considered; before these decisions were made by a small group of people known as a National Disaster Command Council.

Section 27(2) of the Disaster Management Act empowers the ministers to make decisions and even the regulations after proper consultation with the relevant parliamentary ministers: and it is clear that this must also be read in conjunction with Section 59 that clearly deals with an exercise of regulatory power which has been ignored - or even abused. Section 59(1) (i) states that any such regulation must actually all be referred to the National Council of the Provinces - in terms of Section 146(6) of **The Constitution**.

South Africa has a Government that has appointed a National Command Council of only six (6) and it is MEC Dlamini Zuma, as that Minister of Cooperative Governance and Traditional Affairs – COGTA - that makes all the decisions relating to the National Disaster Management in our country. This is clearly all guided by the United Nations and World Health Organisation - and the question is begged at a time of Military Lockdown whether one person alone has that ability: right or even that authority to do this in the absence of the approval from the National Council of the Provinces who have been totally ignored.

Section 146(6) is extremely clear that any law made in terms of the National Disaster Management Act and that the Act of Parliament can only be made with the approval of the Parliament and also National Council of Provinces. This has most certainly not been done - and on the 14th of May 2020 the Lawyers for Constitutional Democracy made a public announcement and sent a Letter to the Office of President Ramaphosa – and declared that the people's rights were under threat; as the direct result this Military Lockdown. The Disaster Management Act 57 of 2002 is presently operating without that Constitutional Mandate or Parliamentary Executive Oversight – and this has resulted in several Constitutional dictates being violated; and in the opinion of the legal profession being invalid and *contra bona mores* or in that language for a layman - and ordinary people – **Totally Unlawful!** The entire process has been unlawful!

South Africa has a Government that sincerely believes it is above the laws of the land: The Constitution and even Parliament – and the Declaration of the National State of Disaster was totally unlawful in the absence of the evidence that there were "Special Circumstances" to warrant and justify the actions of a self-appointed National Disaster Management Council that clearly do not have the interests of people or the nation in mind. The abuse of power has led to the death of people by the SAPS and the SADF and the starvation of millions of people is nothing more than a hunger game to ensure the people of South Africa are dependent on the Government for food and their basic needs. The economy is also in crisis!

Section 146(6) is extremely clear that unless "Special Circumstances" exist in South Africa – and not in any other foreign country – the extreme measures of a Military Lockdown: Closure of the Economy: or the House Arrest of the entire nation is not only unlawful: illegal and Constitutionally invalid but that is also morally offensive and abuse of power when the people have lost businesses: employment: and the right to earn a living. The Freedom of Religion: Speech: Movement: and many other basic human rights have been removed by the President: the Cabinet of 28 Ministers and a National Disaster Management Council that clearly had no justification: ability: right or even Parliamentary Authority; based on only 60 reported cases of a Corona Virus. They did not have the legal right or the ability to deal with that crisis that has not been created by a virus - but rather the Humanitarian Disaster caused by the Government.

South Africa has a Government that sincerely believes it is above the laws of the land: The Constitution and even The People – and the Zondo Commission has yet to provide a single prosecution and also that Anti-Corruption Tribunal has yet to punish a single public servant for acts and omissions since the ANC was appointed into leadership and management in April 1994. More than R400 million has been spent or wasted on the Zondo Commission since 2018 alone and the importance of any civil society oversight committee can neither be opposed: disputed or denied. The importance of **The Second House** and that Voice of Truth: Reason: Wisdom and most certainly that restorative justice cannot be ignored - in 2020.

Section 146(6) of The Constitution is only the one example of where abuse of public trust and power is seen – where there is no respect for the law and the Rule of Law – and there is a Museum of Truth and a Library of Evidence to substantiate the desperate need for investigations: prosecutions: a restorative justice and more importantly, accountability to all the people of South Africa. More than R3 trillion is a conservative estimation of what has been wasted: lost: stolen or unaccounted for in the past 10 years.

SOUTH AFRICA: THE MUSEUM OF TRUTH: THE LIBRARY OF EVIDENCE: **THE TIME FOR ACCOUNTABILTY**

South Africa needs a Civil Government that is capable and moral: and more than 26 years of research is all sufficient evidence to justify that establishment of The National Peace Commission to be The Second House – and the Voice of Truth: Wisdom and Reason. The Letter to the Office of the President was the request for a Summary of Findings on the Zondo Commission: the Anti-Corruption Tribunal: and also an explanation as to the justification for the Military Lockdown: closure of the economy and the starvation of millions of people in a country that is clearly a Land of Plenty. The time has come for accountability!

The President and Cabinet of 28 Ministers has made State of the Nation Address – **SONA** – promises in both 2019 and 2020 and the Premiers in the 9 Provinces have also made State of the Provinces – **SOPA** – promises as that mirror image of that resurrected 2009 National Development Plan. The Ministers of Economic Development: Tourism: and Environmental Affairs – EDTEA – prepare the Budget Speech for the Legislative Council in Parliament with the assistance of the business community - and the business chambers in each province. The Local Economic Development Managers in each municipality spend the ratepayers and taxpayers money to develop strategies and catalytic projects with the Economic Council and Growth Coalitions in the provinces to find ways to stimulate the economy in a sustainable manner.

South Africa needs a Civil Government that is capable and moral: and more than 234 municipalities had only 18 clean audits in the 2019 fiscal assessment. More than 18.5 million people were on social grants in 2019 before the Junk Status and the Covid 19 Military Lockdown. More than R30 billion was spent on only 27 650 senior and middle management in the public sector; at provincial and national levels in this government and municipalities. More than 45% of the entire budget is paid in salaries and bonuses and those benefits for public servants. There are 9 provinces and 234 municipalities and also more than 1.3 million people are employed in the public sector and yet no one understands how the economy works!

The President and Cabinet of 28 Cabinet ministers have all made that 2020 State of the Nation Address promises that no one in South Africa would go hungry: and everyone over the age of 10 will also read a book: and food security and poverty relief and job creation and skills development and transfer are all those priority catalytic projects. The Government has pledged access to funding: reducing the red tape: and even created the Corporate Social Fund: Jobs Fund: and also other creative and innovative ways to extract more finance from the private sector - and even that VAT and local rates and taxes were in less than ten years increased and even doubled to fund all the 701 State-owned enterprises in our country.

South Africa needs a Civil Government that is able to understand only infrastructure and **Batho Pele** – **People First** – service delivery are the only solution to the challenges in our country - and that law and order is required to maintain and enforce law and order – and obedience to the Rule of Law is the duty and responsibility of all public servants. The function of Government is to provide an enabling and also effective and efficient environment to allow investors and the business chambers and corporate sector to stimulate the economy; through socio-economic growth and development. The function of all those public servants is to protect and defend and serve the people that elected them all into a public office.

The President and Cabinet of 28 Cabinet Ministers have all made that fatal mistake to falsely believe it alone has all the power and finances to stimulate a vibrant economy and yet the ministers rely on that private sector to even provide catalytic projects and innovative and creative ideas and strategies for all Local Economic Development: Budget Speeches: and even those State of the Nation Addresses that are designed to promise the people things that they are 'unable' to provide. These truths can no longer be at all disputed: denied: opposed or even ignored as the Government chose to destroy an economy; and then use incompetent and inept leadership and management to attempt to make even more promises!

SOUTH AFRICA: THE JUNK STATUS: AN ECONOMIC RECESSION: AND A HISTORY OF THAT CORRUPTION

South Africa has been plagued by a history of Government corruption both in the past and also in these past 26 years of incompetent leadership and mismanagement of the country. The Peace Commission is in the fortunate position of having a Museum of Truth and a Library of Evidence to support this and this can no longer be ignored by the President and all the Cabinet of 28 Ministers. There are more than 300 cases of unresolved cases that need to be addressed without further delay and are not negotiable: as a need for restorative justice cannot be denied or disputed: and this Government has a duty to resolve it.

The President and Cabinet of 28 Ministers have either tolerated or ignored these acts of corruption and have even been indifferent or even an integral part of the loss of more than R3 trillion that has all been lost: stolen or wasted in the past by that mismanagement; and corruption. A Zondo Commission: Anti-Corruption Tribunal and National Prosecuting Authority failed to provide a single prosecution - and the Special Investigations Unit have been strait-jacketed by a political process that is also controlled by the Office of the President and not a single investigation is approved - without that authorisation from that central decision-making control and even serial criminals are released every single Freedom Day with a presidential pardon. More than 19 000 criminals were also released - in 2020! It defies common sense!

South Africa has been plagued by a history of crime and corruption and human rights abuse - and it is a reality that our country is the Number One Crime Capital of the world - and only second to Mexico with a history of more than 60 murders a day - and these crimes also include human trafficking: drugs: rape: or human rights abuse and domestic violence; with those home and farm invasions becoming a normal everyday occurrence. There is no political will: and neither is the justice system and even a Correctional Services committed to the process of reducing the crime and maintaining or enforcing law and order – but the Military Lockdown received priority and that is the cause of the destruction of an economy in a time of greatest need for socio-economic growth and development. This even defies basic intelligence.

The President and Cabinet of 28 Ministers have chosen to ignore the global warnings from these rating agencies of *Fitch*: *Moody's* and *Standard & Poors* and the result have been Junk Status and Recession in a period of ten years. It has ignored the advice of the business chambers and even chosen to ignore the appeals of the unemployed and the needy and desperate - and for reasons known only to them - these decisions were taken to destroy the economy and play the **Hunger Games** of politicians in order for the people to become totally dependent on a government that has neither the capacity or capability to pull this country out of a Junk Status - and Economic Recession. **This even defies all the laws of economics!**

South Africa has been plagued by a history of rebellion: revolution: wars: and public protests but not at any time has it been reduced to the level of need where food security and poverty and disaster relief is not only a necessity - but a daily need! This country has actually enjoyed an agrarian and agricultural as well as an industrial revolution in the period between 1948 and 1994 and yet the ministers speak of the need for a 4th Industrial Revolution and the rollout of a digital infrastructure. There is the current need for an agricultural revolution and a vibrant economy; and massive inequality exists between the elite in the public sector and those living in the informal settlements. This even defies the laws of conscience!

The President and Cabinet of 28 Ministers have chosen to ignore the cries of the needy: poor: the sick: and the homeless and it defies all logic and basic understanding that this government has chosen to be the architects of this New Dawn of Hunger Games: Military Lockdown: Economy Destruction: and that increasing poverty and deprivation of basic human needs and rights that are enshrined in the Freedom Charter of 1955. **The Second House** is The Peace Commission - and this Government is being given that Notice in Terms of Section 3 of the Institution of all Legal Proceedings - of the State Act No 40 of 2002.

SOUTH AFRICA: A HISTORY OF CORRUPTION: THE DAMNING EVIDENCE: **AND THAT ACCOUNTABILITY**

South Africa has a shameful history of crime and corruption; and none more corrupt than what is seen in the past 26 years and the reasons for this is the silence of the 80% Christian majority and that moral minority in Civil Society. The lack of political will and the control of the justice system and judiciary has highlighted the sad reality that there is no separation of powers - and The Church and State are neither separated nor controlled by each other but the Government has attempted to regulate and control it in the past 26 years with various Organs of State – such as a Chapter 9 CRL Rights Commission: and also a National Interfaith Council of South Africa - and even the South African Religious Forum. The more than ever evidence of this need to regulate and control The Church is seen in the *Government Gazette* that seeks to control the movement of more than 75 865 churches - and 80% of the entire population by it.

The President and Cabinet of 28 Ministers and their National Disaster Management Council has also in recent days provided the Notices and Regulations for the Level 3 Compliance – and it includes those in which all church and religious leaders are expected to comply with these 'dictates'. The Government is **The First House** and is responsible for the separation of Powers between the Executive: Legislature and the Judiciary and it has a duty and responsibility to heed the advice and warnings of The Church; and all Civil Society. This is **The Second House** and it provides that Voice of Truth: Reason and Wisdom to Civil Government in a spirit of collaborative cooperation - and mutual respect for that separation of powers.

South Africa has not enjoyed this essential component and The National Peace Commission was then established to provide that important element that guides the Government on policies - and also that which affects the social: economic and political future of the country. In the absence of this Voice the Humanitarian Disaster: Economic Crisis: and Political Instability is the predictable result. There cannot be economic certainty: socio-economic growth and development or any confidence by investors - that makes that vibrant economy possible. The Government has done everything in its power to ensure that none of this can be achieved and the *politics of hate* has created further division and destruction of the racial: cultural and social cohesion. The Government has not provided the **Ten Principles for Freedom**.

The President and Cabinet of 28 Ministers and their National Disaster Management Council has also in a very short period of time demonstrated that they neither have the ability: right or authority to lead a country and manage the resources — or even deal with virus that has yet to be proven dangerous to the health and safety of an entire nation: the economy: and the future of the country. They have destroyed the economy and the lives of millions of people in the false belief it is in those interests of public health or safety. There are no special circumstances to justify what this Government has done and there is not an ounce of evidence to justify the extreme measures taken to heal the nation of an invisible virus that has most certainly destroyed the economy and public trust - by the actions of all these public servants.

South Africa has not enjoyed this overreaction: or any of these acts or omissions that the Government has perceived as "Special Circumstances" and sufficient to justify their extreme measures. The Office of the President has falsely believed that the ANC Government has the power over The Church: and all Civil Society and even the Business Chambers; and yet it has not kept its own House in order and there is more than sufficient evidence to prove that this statement of Truth is both relevant; and supported by a Museum of Truth and a Library of Evidence and there can never be Peace or Freedom in our land while the Government continues to falsely believe it is above the law - and does not obey the Rule of Law: and even believes it can regulate and control both this economy - and even The United Church!

The President and Cabinet of 28 Ministers and their National Disaster Management Council have all in a very short-sighted period of poor leadership and mismanagement failed to prosecute all the corrupt.

SOUTH AFRICA: THE NEED TO SHAME AND BLAME: THAT NEED TO EXPOSE IT: **AND THEN PROSECUTE**

The National Peace Commission sent a Letter to the Office of the President and the Cabinet of 28 on the 28th of April 2020 - with specific requests for the Summary of Findings on The Zondo Commission: The Anti-Corruption Tribunal: and the Justification for the Military Lockdown. These were also done in a Spirit of Ubuntu – Respect Others – and Batho Pele – People First. It was done respectfully and with an understanding that those same 11 Principles of Batho Pele would also be applied to that response.

The National Peace Commission was established to be **The Second House** - and to act as an 'oversight' committee to the Zondo Commission and the Anti-Corruption Tribunal - and this request was not seen as mutually beneficial in 2019 – and the offer was rejected by those decision-makers in government. It also provided a R5 Billion 5 Year project that dealt with food security: poverty relief: pollution; and also practical solutions to unemployment: skills development and job creation and this too was not actually supported by government although it was exactly what was required to deal with an increasing poverty and pollution in the 550 informal settlements in Kwa Zulu-Natal. It is clear that the Ministers of EDTEA – Economic Development: Tourism: and Environmental Affairs – are looking for solutions from those in the business chambers and private sector for Budget Speeches - but actual projects or solutions are not accepted unless there is some financial advantage; or a personal interest in that entire funding process.

The National Peace Commission sent a Letter to the Office of the President - and the Cabinet of 28 - on the 28th of April 2020 - with a legitimate expectation that the President would have welcomed both an opportunity to demonstrate those Batho Pele Principles - and also to be willing to release information; and welcome an oversight committee that acted in the best interests of civil society and the nation. It is in the best interests of everyone to display moral leadership and best practices; and the following is an example of the information that is already in the public domain – and as yet no one in 26 years has ever been prosecuted for these acts: omissions and serious offences: and more than 300 are yet to be resolved. These are only some of the many cases that include all the government and municipalities:

- 1. The multi-billion Rand Arms deal that was concluded in 1990's and has yet to be concluded.
- 2. The multi-billion Rand Road Accident Fund fraud and Manase Report at eThekweni Council.
- **3.** The multi-billion Rand VBS Bank scandal and that prosecution of the Municipal employees.
- 4. The multi-billion Rand Ngonyama Trust scandal and corruption in that land reform process.
- 5. The multi-billion Rand Gupta Family State Capture scandal and those related coal contracts.
- **6.** The multi-billion Rand FIFA World Cup Stadium construction and all of those State contracts.
- 7. The multi-billion Rand RDP Housing Contracts and all involvement of Municipal employees.
- **8.** The multi-billion Rand ESKOM and State-owned Enterprises and all of those State contracts.
- 9. The multi-billion Rand Municipal Supply Chain Management Contracts and also those audits.
- **10.** The multi-billion Rand Government Supply Chain Management Contracts and also the audits.

The National Peace Commission was established to be **The Second House** – and to ensure that capable and ethical leadership and management was placed into positions of public trust and support includes:

- **1.** A Museum of Truth: and that Library of Evidence.
- 2. The Daily Tabloids and the Carte Blanche recordings.
- 3. A Daily Maverick Score Card on the Cabinet of Ministers.
- **4.** The Auditor General and the audits on 234 Municipalities.
- **5.** A Daily Media Report on the on-going reports of corruption.
- **6.** The Global Business Confidence Index Report and Junk Status.
- 7. The Auditor General and audits on 701 State-owned Enterprises.

SOUTH AFRICA: THE NEED FOR COLLABORATIVE JUSTICE: RESTORATIVE JUSTICE - AND THE TRUTH!

South Africa has been deceived and betrayed! The COVID 19 Plandemic has been exposed as being a hoax of global proportions and the Letter to the Office of the President was to provide the president and the Cabinet of 28 Ministers and also the National Disaster Management Council with the perfect opportunity to reveal their interests in this COVID 19 perceived threat to the future of our country; in terms of safety and national health. The COVID 19 Plandemic was planned by global elitists and this is planned to introduce a variety of changes that are also described as Radical Economic Transformation.

- 1. South Africa's military and SADF lockdown is known as LOCKSTEP and was developed by that partnership of the World Health Organisation and also Bill Gates and Rockefeller Foundations and it is not only totally unlawful but also unreasonable and unnecessary in relation to all other deaths experienced in this country. The Military Lockdown is the declaration of war on nations.
- **2.** A State of Emergency or State of National Disaster can only be declared by an Act of Parliament as in *Section 37 of Chapter 2* in the Bill of Rights as part of the 1996 Constitution in South Africa.
- **3.** South Africa's President and the Cabinet of 28 Ministers and their appointed National Disaster Management Council under the MEC for Cooperative Governance and Traditional Affairs have only filed 'Notices' in the Government Gazette and not actually passed any required Acts of Parliament. It has claimed to be an 'Advisory Council'- or National Disaster Command Council.
- **4.** A *Government Gazette Number 43365 in Volume 659* was submitted on the 28th of May 2020 to regulate and control The Church and 80% of the population; and is not even constitutional.
- **5.** South Africa's State of Emergency: Military Lockdown: Closure of the Economy: House Arrests: SADF and SAPS Arrests: and the Hunger Games of the Government: and the restriction of the access to information: and Loss of Freedom is unlawful: illegal: abuse of human rights: and an act of war against the people. Most of all it is a crime against humanity and people in a country.
- 6. South Africa's President and the Cabinet of 28 Ministers and the appointed Disaster Command Council have most certainly not acted in the best interests of the entire population and these acts of infamy and omissions will not go unpunished and will be seen as an ultimate betrayal of public trust in the annals of history. These people and public servants acted outside of their Parliamentary Mandate and Constitutional Authority and believed they are above Rule of Law.
- 7. South Africa's SADF and SAPS were mobilised to bear arms against vulnerable people; and this was based on the perceived threat of a virus that has been exposed as nothing more than that elaborate plan to oppress the people and impose mandatory vaccinations and 5G Technology.

South Africa has been deceived and betrayed! This truth cannot be opposed: disputed: or denied and it was the decisions of the Office of the President: the Cabinet of 28: and also the Disaster Management Council that reduced this country to a nation of beggars and oppressed citizens. The entire process in a hurting and troubled country of many tribes: races: cultures and nations has been 'orchestrated' and in reality planned by a small group of public servants - that had no ability: no legal or lawful right: and not any Parliamentary Authority to bring into being what has been exposed as the ANC New Dawn Plan to introduce Radical Economic Transformation – RET. The COVID 19 Plandemic was their weapon of war!

South Africa has been deceived and betrayed! The ANC Political Party and their SACP and Cosatu group of unions has deceived the people of South Africa by bringing in a Communist Shadow Government and even introduced Chinese Policemen - and Cuban Doctors - to deal with the Covid 19 Plandemic. SOUTH AFRICA: THE ULTIMATE BETRAYAL OF PUBLIC TRUST: MILITARY LOCKDOWN: HUNGER GAMES!

South Africa has a history of betrayal and deception! The ANC Political Party established a Communist Shadow Government and developed contracts with a Communist BRIC Partners to dispose of minerals: resources: natural capital: and even our National Heritage of noble metals: rare earths: precious stones and even the fertile soil that covers this treasure chest that is seen and envied by the Communists; as a geological freak of nature. An Ocean Economy and Maritime Accords and Biodiversity Programmes are products of the Department of Economic Development: Tourism: and Environmental Affairs - and their Cabinet of 28 Ministers: Organs of State: and even their Local Economic Development Managers in 234 municipalities and 9 provinces to develop Spatial and LED strategies in line with National Develop Plan.

The Business Chambers: Traditional and Religious Leaders: and even the wider community participated in the process that would bring that 2009 National Development Plan to life - and even a KZN Economic Council and KZN Growth Coalition were established to identify catalytic projects that would attract the investors to the country. These Catalytic Projects had very clear guidelines - and this was a model that never changed from 2009 until 2020 in terms of the 7 elements the Premier and all these Departments of Economic Development and all supporting Organs of State and municipalities used to promote them in the provinces; and local municipal regions. They were never changed - and included these elements:

- **1. Job Creation** and dealing with the methods to stimulate employment.
- **2.** Food Security and dealt with all strategies to provide that essential need.
- **3.** Poverty Relief and dealing with interventions to support the growing demand.
- **4.** Crime and corruption and dealt with the challenges but were never implemented.
- 5. Infrastructure and service and dealing with all these needs but were never provided.
- 6. Rural and Township Economy and dealt with the problems but were never developed.
- 7. Improved Public/Private Sector Partnerships and dealing with a need to get the funding.

The Business Chambers: Corporate Sector: Civil Society and the wider community were involved in the planning processes but the Catalytic Projects were selected by public sector interest groups - and that access to funding was provided to projects that benefited decision-makers; and the focus was on those that complied with the Affirmative Action: Equity Bills: Land Reforms and BBBEE policies and this has in no way changed since 1997. The ANC Government made sure that minority groups were excluded from the mainstream economy - while building support for their land expropriation and land reform policies.

South Africa has a history of betrayal and deception! But never in the annals of history has government stooped to the levels of Hunger Games: Military Lockdown to destroy the economy: or establishing the foreign police stations - in order to achieve a Communist objective of Radical Economic Transformation at the expense of the economy and starving masses. The Media was used to promote all this deception and fear mongering and which has now been exposed as a global hoax and plan to depopulate a nation for the benefit of all coalition partners in this elaborate plandemic. More than 300 000 unborn children are butchered every year legally under the 1997 Abortion Bill and it is a solution to poverty provided by United Nations: World Bank: International Monetary Fund - and promoted by Rockefeller Foundation.

The Business Chambers: Corporate Sector: Civil Society and the wider community were deceived by the architects of this global plan and The National Peace Commission was established in 2019 to expose all the acts and omissions of this Government. The South African Christian Chamber of Business and Civil Society have embraced this challenge with an attitude that refuses to fail and the Office of a President Cyril Ramaphosa and the Cabinet of 28 Ministers have been given notice to explain their involvement in this genocide against not only the minority groups - but also their businesses and the starving poor!

SOUTH AFRICA: THE NEW CHINESE COLONISTS: THAT COVID 19 PLANDEMIC: **AND THAT NEW DAWN**

The National Peace Commission was established out of a desperate need to find a peaceful solution to the situation facing South Africa. It was established in October of 2019 and represents the Civil Society: the 80% Christian majority: the business sector and wider community; and most importantly the 4 race groups - that are concerned about the future of South Africa. There is no United Voice and there is that need for Truth: Wisdom: and Reason — as well as restorative justice and righteousness in a country that seldom hears the truth; and where justice has always been delayed and denied. Righteousness is never recognised or rewarded and there is a current need to provide the platform for interest groups to unite in solidarity; to bring about that process - and framework for change. It is the perfect agent for change.

South Africa is facing the threat of Communist Chinese Control and Colonisation by people that are also in desperate need of expansion; and mineral resources as well as the fertile land for all agricultural and agrarian development. There are both internal and external threats facing this country and there are the interest groups and money lords and war lords that have their own agendas. We have the benefit of hindsight and meticulous research - and a Museum of Truth and a Library of Evidence; and none of this can be opposed: disputed or denied. It is important that the present Government and the Council of 28 Ministers reveal their intentions to these people of South Africa - sooner rather than later! There is a peaceful solution to the challenges and this is not something that will be discussed or debated in this document - but the country needs peace and the freedom - that was promised in **The Freedom Charter** in June 1955. It is the time to face this Truth.

- **6.** A National Legislature A Law-making Body where The First House is elected by the State.
- 7. A Separation of Powers A Separation of the Executive: and a Legislature and that Judiciary.
- 8. A Free Market Economy A Right to own a Property and Free Trade and not that State Aid.
- 9. An independent Judiciary A Justice Department where everyone has the right to a fair trial.
- **10.** An Education Programme A parent-controlled teaching of values and content based wisdom.

South Africa desperately needs a Civil Government that is structured in a manner that provides all the essential infrastructure to guarantee that Peace and Freedom: Economic Certainty: Political Stability: and investor confidence. In the absence of these basic principles there will never be peace or freedom and The Church and the State needs to be separate - and The Second House is there to guide the State on all matters of social: economic and political importance. There is no such thing as withholding any information - on the basis of national security. There is no such thing that exists where the State has a sole right to declare a Military Lockdown based on the need for national health and safety and there is no wisdom in destroying the economy and starving millions of people based on a perceived threat of a virus that has been exposed as being nothing more serious than a common cold - or winter influenza!

The President and the House of 28 Cabinet Ministers need to decide today who they actually serve as it is clear that the best interests of the people in this country and the economy have not been taken into consideration. It is an undeniable fact that restorative justice needs to be seen: and Zondo Commission and Anti-Corruption Summary of Findings needs to be made available - sooner rather than later in that spirit of Batho Pele. The People of South Africa deserve to know the Truth and demand accountability.

The National Peace Commission hereby provides a Summary of Findings on the State of the Nation and is Sending this Letter to the Office of the President in order to gain clarity on all matters that are raised.

<u>SPECIAL NOTE</u>: This Document is the Intellectual Property of The South African Christian Chamber of Business and The National Peace Commission. It is the Follow up Letter to the Letter to the Office of the President sent on the 28th of April 2020. The initial Letter respectfully requested accountability on the reasons and justification for the Military Lockdown: Closure of the Economy: and extreme Hunger.

In addition to all these requests the Office of the President was respectfully requested to disclose that Summary of Findings on the Zondo Commission that had been established in 2018 and also a Summary of Findings on the Anti-Corruption Tribunal. The Reasons making these requests was that more than R400 million had been spent on the investigations and cross-examinations with no sign of prosecutions on the Zondo Commission. The Anti-Corruption Tribunal has yet to provide information - on all cases.

The National Peace Commission was established in October of 2019 to provide an oversight committee to both the Zondo Commission and also the Anti-Corruption Tribunal. The need for the Second House — a Voice of Truth: Wisdom: and Reason — and represented by all sectors of Civil Society was realised and the support gained at both a national and global level has resulted in the establishment of the Council of 28. It is representative of all race and gender groups: all religious and traditional leadership: and the business chambers and corporate sector. It is also supported by rural community - and informal sector.

<u>CONCLUSION</u>: This Document is the result of meticulous research: and extensive preparation and it was also deemed necessary to bring to the attention of the Office of the President - and the Cabinet of 28 Ministers in the ANC Government – that the Summary of Findings regarding the State of the Nation in 2020 are cause for serious concern. There are more than 550 informal settlements in Kwa Zulu-Natal: and millions of needy and destitute people of all races have been negatively affected by the closure of the economy: the military lockdown: and the house arrest of people in both the public and private and institutional sectors. The procedure that has been followed to implement this is questionable; and this is a matter for public record. South Africa needs answers to these questions - and that accountability.
